CONFIDENTIALITY AND LICENSE AGREEMENT

THIS CONFIDENTIALITY AND LICENSE AGREEMENT (this "Agreement") is made and entered into this day of , , by and between the Department of Navy, specifically the Environmental Programs Office (AIR 1.6) of the Naval Air Systems Command (NAVAIR), a United States Government entity ("the Government"), and the person or entity signing as "Recipient" below.

1. Definitions. For purposes of this Agreement, "Information" shall mean the information referred to in any documents, technical data as defined in DFARS 252.227.7013(a)(14), models, special machines, test procedures, business activities and plans, demonstrations related to any information exchange with AIR-1.6 as well as any other information related to the Programmatic Environmental Safety & Health Evaluation Document Authoring Tool (PESHE DAT), or any other information that may or not be labeled "Confidential" (or any similar type marking such as Proprietary) by or provided to Recipient by the Government with reference to this Agreement. Such Information excludes, however, any information that (1) has been or is obtained by Recipient from a source independent of the Government and not desiring such information from the Government, (2) is or becomes generally available to the public other than as a result of an unauthorized disclosure by Recipient or its personnel, or (3) is independently developed by Recipient without reliance in any way on the Information or Materials provided by the Government. "Materials" shall mean, but not be limited to, all memoranda, technical data as defined in DFARS 252.227.7013(a)(14), notes, records, drawings, manuals, disks, or other documents and media pertaining to the PESHE DAT, including all copies, extracts, and summaries thereof, containing any Information or provided to Recipient by the Government with reference to this Agreement.

2. Limited Use. Recipient acknowledges that it is to be given access to Information and Materials for purposes to (1) perform services under Contract and/or (2) perform activities in accordance with a mutually agreed to and signed Memorandum of Understanding (MOU). Recipient agrees that (1) it will not use the Information except for authorized purposes described in a Contract or a signed MOU, (2) will keep the Information confidential at all times, and (3) will not copy or modify the Materials or technology, or any copy, adaptation, transcription, or merged portion thereof, except as expressly authorized by the Government. Recipient shall limit its disclosure of the Information and Materials to employees within its own organization whom the Government could reasonably expect to have a legitimate need to receive such Information and Materials in order to accomplish the Authorized Use (only for evaluation as listed above). Recipient also shall insure that all personnel afforded access to the Information and Materials shall protect such material against any improper use or disclosure in a manner consistent with this agreement. Recipient further agrees that no copies of any Information or Materials shall be made without United States Government's further written consent.

3. Proprietary Protection. The Government shall have sole and exclusive ownership of all right, title, and interest in and to the Information and Materials, including ownership of all copyrights, patents and trade secrets pertaining thereto, subject only to the rights and privileges expressly granted by the Government. Any improvements made by Recipient to said Information shall become the exclusive property of the U.S. Government.

The Government claims and reserves all rights and benefits afforded under federal and international copyright and patent law in all software and hardware technology included in the Materials. The binary or object code version of software programs and hardware technology used
